7.2.1. National Ride Standard

Report from Kim Moir - information received from Tom McCormack that the National Ride Standard was a 3-year project from 2011 – 2013 to establish a standard for how rides would be organised; noted motion from July 2010 to support funding by AERA.

Recommendation that this is no longer required to be identified as a separate portfolio with reporting requirements.

Recommendation accepted but reminder that the same standards still need to be upheld and monitored.

8 Correspondence Inwards

8.1 Correspondence Inwards

8.1.2.7 Matthew Walker re research project - email received 25 February 2020

Matthew has put forward a proposal to study the risk factors influencing invasive treatment rate in endurance horses in Australia. He has stated his willingness to sign an agreement to support the integrity of the process and AERA, before sharing any data.

Note that a Data Usage Agreement, draft shared with delegates, is still to be approved by AERA and that any access to AERA data would be dependent on such an agreement being signed.

Discussion

Concerns included:

- that there should be no use of membership numbers or logbook numbers and that these
 details are not required to aggregate data or to draw conclusions;
- that there is a lack of information and that we might ask for further information;
- assumptions are not listed and concern that these can change results if not acknowledged;
 they are crucial to statistical analysis;
- concerns about privacy issues, potentially unauthorised access to the database; consent
 for use of information by owners, Zoetis, etc; what information has been transferred from
 the Zoetis horses4health database to AERA database; is there an agreement about how
 Zoetis information is used and how it is linked to AERASpace; has consent been given for
 publication of microchip numbers, noting that vets gather that as sensitive information. A
 list of questions about how AERA is managing privacy of information and how it is
 managing the use of data that for purpose other than that for which it has been gathered
 has been put forward;
- principle concern is about access to our data to satisfy ourselves that the process so far
 has been ok, and we are not exposed in any way and that we are operating with all
 legislative requirements;
- any research should be consistent with the objects of the Association;
- note that Matt Walker is an active endurance vet and concern was expressed this access would allow him to have access to a level of information that may prejudice his decisions.

Comments:

- that Data Use Agreement could take care of some to the privacy issues and will specify how data may be used;
- use of membership numbers or logbook numbers may be used just to provide an initial system to manage data but would not be allowed in any final public document;
- when the outcomes of projects are presented, we will be able to see assumptions, any breaches of privacy and have these managed before any publication;
- Pat's questions to be circulated to all MC members to allow for full consideration.
- Connection between Zoetis and AERASpace dropped out early last year and was restored; connection has been given since 2016 when vaxed only rides were first introduced to allow ROs to confirm vaccination status of horses;

- · Objects of Association include support of research;
- What is the purpose of the data we gather?

Actions

Request for more information from Matthew Walker to support AERA's decision-making and that he will be required to sign a Data Use Agreement.

Pat to circulate questions for consideration and AERA to consider what advice is provided to members about use of information.

8.1.1.8 Jewel Azaria Tan - asthma in horses

Request to publicise survey to members via Facebook and Website. Members who sign in will be asked to complete a 15-minute survey; project has ethics approval through the University of South Australia. Survey is open until 27 April 2020.

Concerns included:

- Survey is being promoted by an international company that is likely to benefit from the results of the survey;
- Members data may then be mined by the companies involved.

- commercial interest has been disclosed:
- considered a worthwhile project given the amount of respiratory illnesses being seen;
- this is being done through a University and has ethics approval.

9. Late Agenda items

9.1 Correspondence WAERA re TQ20

Correspondence was received to this agenda as it related to discussions from an earlier part of this adjourned meeting. Advice had been sought by AERA to inform further discussion about TQ20 and the impact of the COVID-19 restrictions.

Significant points from WAERA Correspondence:

 The probable need to postpone this event is beyond the control of WAERA and the TQ20 Ride Organising Committee and has been influenced by government and AERA decisions regarding restrictions imposed due to DOVID-19. AERA Agenda 21st and 22nd March 2020.

 The suggested date of 1 May for a decision to be made is about capacity of the committee to finalise contracts from suppliers and to resume preparation to have everything in place for a September event.

- The current restrictions will impact on preparation and qualifying of horses to be ready for a September 160 km.
- Hosting a Tom Quilty event is offered to States/DAs with relevance to AERA's objects to maintain Division Associations and to foster endurance. This is an AERA event.
- WAERA members are disadvantaged due to location from attending other Quilty events.
- WAERA has already invested significant funds to support TQ20 in WA.
- Significant sponsorship has been committed and will still be available in 2021 but may not be committed beyond that. Sponsors have written supporting letters to this effect. Also, significant amounts of sponsorship money have already been spent.
- Preparation for TQ20 qualifies the committee to be able to host TQ21 and the committee is able to keep going until 2021.

Clarification sought from WAERA about their wish to postpone the TQ20 as scheduled from September 2020.

- WA is in firm shut down and there is no sense of when this will change though it is anticipated to be
 at least 6 months; this related to movement into and out of the state and also between regions of
 the state. Most recent announcement by WA Premier, just prior to this meeting suggested borders
 would be closed for possibly 6 months.
- Decision-making had been discussed at meeting on 25 March and it was determined that though this was a decision to be made by WAERA/TQ20 that any announcement would be done in conjunction with AERA.
- Any notice to members should give some clarity about when the next Quilty event will be held and where.
- It is WAERA's preference that the TQ scheduled for September 2020 is postponed and WAERA is allowed to host this event in 2021.
- WAERA could stand to make a loss of \$55,000 and could face bankruptcy.
- Linda advised that initial discussions with NSWERA had occurred and they had requested much
 the same information that AERA has sought from WAERA. They wanted a proposal that outlined
 options about when they would host their TQ event.

Comment sought from NSWERA about their thoughts:

- NSWERA has not yet had the opportunity to discuss as a MC group with TQ21 Committee and
 would like to receive more formal advice on options that might be considered to inform this
 discussion. Any decision from NSWERA would be made in conjunction with the TQ21 Committee.
- Requesting advice on behalf of NSWERA and TQ21 what are the other possibilities other than running a Quilty in WA in 2021; it could be there are other options without impact on TQ21 in NSW.
- NSWERA delegates would not decide without consulting fully with their MC and with the Quilty committee.

Discussion

As AERA, all MC members need to consider the financial impacts on AERA. This year's income is affected by less rides and a WA Quilty does not bring income so to move the WA Quilty to 2021 will result in little or

no income for 2 years. A NSW Quilty will have anywhere from 250 – 300 entries; WA will have 100 to 120 entries.

Reminder that this is no one's fault and something we have to manage. This is a government decision to suspend most activities and this means that TQ20 most probably cannot happen.

AERA has the capacity to make a decision but the preference is that we involve members in the decision-making process and fully consider all options that may be brought to the table.

Reminder that the decision to rotate the Quilty was based on fairness and giving all members access to the national event. It has become an income stream for AERA over the 6-year period, but it is also a significant income stream for the host DAs – at present WAERA is out of pocket and hosting the event in 2021 would support their recovery. NSWERA hoping to run in 2021 and an option would be for WA to run in 2022.

WAERA has suggested that they needed to know by 1 May and that this allowed some time for NSWERA to have discussions and for a resolution to be reached. The preference from WAERA was to announce the decision about the WA Quilty at the same time as any decision about the future Quilties.

Members in WA are isolated, and it is a major thing for them to attend the Quilty.

AERA's responsibility is also to consult with everyone who might be impacted but the decisions we make – if there is a reasonable alternative this needs to be considered. We have to live with the impact of Corona virus.

NSWERA proposed a possible solution for 2021 to be NSW and WA to go to 2022 – WAERA has said that this is not an option for them.

WAERA noted that they are very cognisant of the fact that this is not an easy decision to make.

Agreement to wait until 1 May to allow for full discussion and any announcement to provide information about where TQ21 will happen and the Quilties thereafter.

Consultation will occur with NSW.

Other matters that arose from discussion;

 Event Insurance – WAERA indicated that they had thought this was covered in AERA insurance policies – need to clarify this in manual.

9.2 Correspondence WAERA re members of AERA Sub-committees.

Portfolios were allocated at meeting on 4 April with further discussion relevant to correspondence from WAERA regarding status of a WAERA member.

Conflict of interest

Linda Tanian suggested that due to the sensitivity of this matter and as Elsje was a member of the WAERA Management Committee, she had a conflict of interest and was asked to leave the meeting. Elsje agreed but asked if she was entitled to respond to Dick's comments on his email.

Linda invited Elsje, in the interest of fairness, to make comment.

Elsje commented on the need for AERA to respect the decisions made by DAs and restated the position of WAERA on the merits of the appointment of leva Peters to the Facebook Sub-committee.

Decision that it was appropriate for leva Peters to continue as a member of Sub-committees for AERA Awards, Facebook and as a member of the AERA Quilty Advisory Panel.
