# **FEES AND CHARGES BYLAW**

#### **PURPOSE**

The purpose of this Bylaw is to identify the procedure for setting the fees to be charged, how those fees are calculated and information around the timelines for setting and paying these fees.

This bylaw will achieve a consistent approach to the structuring of fees and provide information to incoming Management Committee members on the fees levied by AERA.

### **FEES TO BE CHARGED**

AERA charges fees to attribute to costs of the Association:

- 1. Affiliation fees, applied to all rider memberships and ride entries, to contribute to administrative expenses.
- 2. Horse Registration Fees to contribute to the ongoing development and maintenance of AERASpace.
- 3. Public Liability recovery fee.
- 4. Administration fee on services provided by AERA.
- 5. Any other fee that is imposed from time to time

Administrative expenses of the Association are:

- General Expenses audit, bookkeeper, computer software, EA Affiliation, printing, stationery, phone, postage, depreciation.
- Insurance costs –Association Liability and General Property
- AERA website
- AERASpace
- Honorariums
- Year-end awards
- AERA expenses related to running of Tom Quilty Gold Cup events, including
  - o provision of Winner's Cup
  - o payment of fees and travel and accommodation expenses for Senior Vet Team
  - o payment of travel and accommodation expenses for Senior Chief Steward Team
  - Team Competition badges and winning team trophies
  - Pat Slater sashes and keepsake trophy
  - o outlay on manufacture of buckles in line with budget presented by TQ Committee.

Horse Registration Fees include:

- Endurance Horse lifetime registration
- Endurance Horse annual
- Horse ownership transfer

Public Liability Insurance is recovered via fees charged per DA, per event, per member.

AERA will invoice DAs for any shortfall of Public Liability Insurance to ensure that adequate funds are available to meet this expense at the beginning of the following year. This action would be brought forwards as a motion from the Treasurer, to be invoiced in October, proportional to the DA membership of the previous year.

Personal Accident for Volunteers is recovered by a fee applied to each event.

An Administration Fee of at least 10% is charged on products sourced by AERA and administered by AERA. This includes

- sale of merchandise track marking resources, logbooks and stationery
- manufacture and sale of Electronic Timing Systems
- receipt and processing of Personal Accident Insurance
- manufacture of buckles for TQ events, including special buckles.

#### Other fees include:

- the recovery of expenses related to AERA Meetings and the travel costs of officials attending TQ Gold Cup events. These are charged to DAs, proportional to previous year's membership; for example expenses relating to TQ21 will be charged based on DA membership numbers in 2020.
- An affiliation fee applied to nomination fees for TQ events and charged to the TQ Committee after the event.

### **CALCULATION BASIS OF FEES**

Fees are based on a user-pay methodology.

Fees are set by the AERA Management Committee, based on a review of the financial status of AERA. Fees are determined by November of each year and advised to DAs by mid-November.

### **FEE SETTING TIMELINE**

Discussion re fees commences in July including review of insurance.

Discussion re vet fees and honorarium is included in agenda for November meeting.

## **FEE PAYMENT TIMELINE**

Sale of all merchandise and products sourced by AERA must be paid before shipment – track marking resources, logbooks, timeslip books, electronic timing system.

DAs are invoiced monthly for affiliation fees to be paid within 28 days.

DAs are invoiced as required for costs to be recovered proportional to membership to be paid within 28 days.

#### **FEE STRUCTURE CHANGE**

Any change to a fee structure to be imposed by AERA to DAs, or to ROC and Members via the DA, must be approved by AERA MC with a motion supported by the majority of members.

The Treasurer will advise the AERA Bookkeeper, and the Secretary will advise DAs by written correspondence.

## **NEW FEE PROCESS**

Any change to a fee structure to be imposed by AERA on DAs, or on ROC and Members via the DA, must be approved by AERA MC with a motion supported by the majority of members.

The Treasurer will advise the AERA Bookkeeper, and the Secretary will advise DAs by written correspondence.
